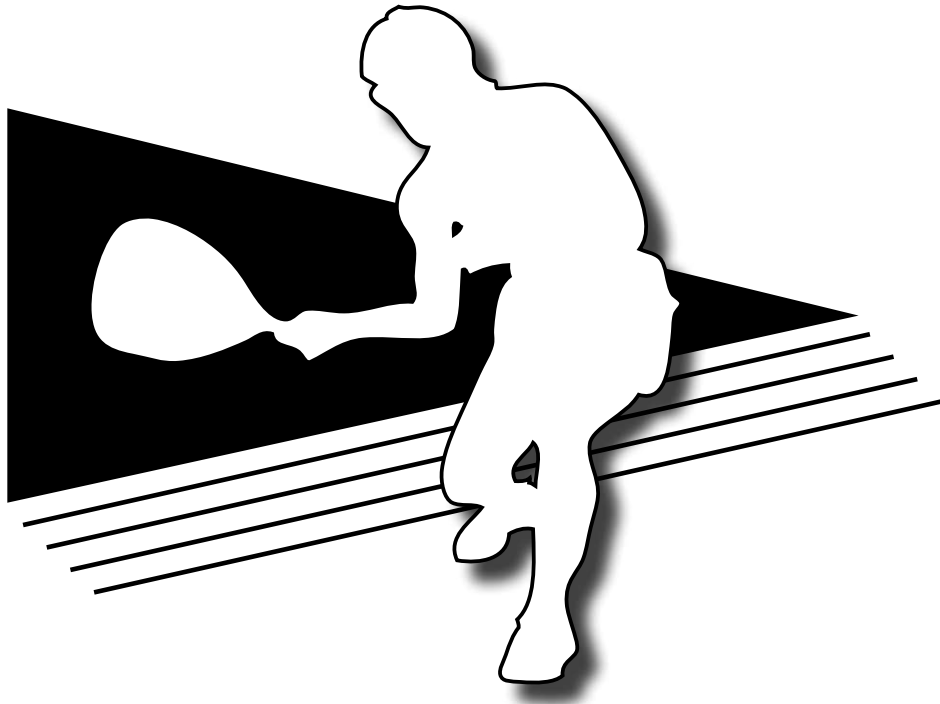

Rules:

Top seeded players start on the higher courts.
First one on the court serves first.
Games are timed (7 min.) and scored (no limit).
At the end of 7 minutes, winner moves up (towards court 1) and loser moves down a court (towards higher number courts).
If score is tied, you play one more rally.

30 seconds in between games. Winner is determined by games won, points given up. All players need to arrive 30 minutes prior to their starting time.

Players must be committed to play the entire time.
USRA-approved eyewear is mandatory. Shuttle Coordinator reserves the right to re-classify any participant.

- Cost: \$15 per person
- DO NOT PAY FOR SHUTTLE AT THIS TIME.
- Players must bring \$15 CASH on the day of the shuttle to play.
