## RULES & REGULATIONS

1. The USTA rules and the "Code of Ethics" will be in effect. The point penalty system will also be in effect.
2. Check in time is 15 minutes before the scheduled match. Default time is 15 minutes after the scheduled match.
3. Balls will be provided.
4. Matches will be best two out of three sets with a ten-point super tiebreak instead of a third set. Consolation round matches and large round robins may be 8 game pro sets depending on available courts.
5. Your age on January 31, 2020 determines the youngest event you may enter.
6. This is a USTA sanctioned junior tournament. All entrants must be USTA members.
7. There will be a consolation bracket for entrants who lose their first match. Check with the tournament director about potential consolation matches.
8. You may enter online at the USTA website, with a paper entry or Google Documents.
9. You may enter up to **3 events**: 2 singles + 1 doubles **or** 1 singles + 2 doubles
10. Matches may start as early as 4:30pm on Wednesday-Friday. Scheduling considerations will be made for players from outside the Anchorage area.
11. **If you have any scheduling requests, contact the Tournament Director before Saturday, February 15.** Further conflicts, except those caused by unavoidable draw issues, need to be worked out by both players and the tournament director informed.
12. **List a phone number** when you register online so the Tournament Director can contact you if necessary.
13. Players are responsible for checking the draws online. The draw will be posted Monday, February 17th.
